Dear Reader,

The Vermont Agency of Agriculture, Food and Markets has developed a comprehensive approach to the regulation of farms in the state in order to best protect water resources. The development of a three-tiered approach to the regulation of Vermont farms allows for a logical progression in regulatory oversight as a farm grows in size from a small farm subject to regulation under the Accepted Agricultural Practices Regulations, to a Medium Farm Operation (MFO) regulated under the state's Medium Farm Operation General Permit to a Large Farm Operation (LFO) regulated under an individual LFO permit.

Accepted Agricultural Practices (AAPs) are the foundation of Vermont's Agricultural Nonpoint Source Water Quality Program. AAPs are a group of farmland management activities that are designed to conserve and protect natural resources by reducing nonpoint source pollutants such as sediments, nutrients and agricultural chemicals that can enter water resources and degrade water quality. All agricultural operators are required to conduct their farming activities in compliance with the AAPs, even medium and large farms operating under permits.

The Medium Farm Operations (MFO) program allows medium sized farms to seek coverage under a single Vermont state **General Permit**. The General Permit prohibits discharges of wastes from a farm's production area to waters of the state, requires adequate and satisfactory waste storage and requires manure, compost, and other wastes to be land applied according to a nutrient management plan. All dairies with 200-699 mature animals, whether milking or dry, qualify as a MFO. Other common MFOs include beef operations (300-999 cattle or cow/calf pairs), youngstock and heifer operations (300-999 youngstock or heifers), horse operations (150-499 horses), turkey operations (16,500-54,999 turkeys), and egg facilities (25,000-81,999 laying hens without a liquid manure handling system).

The LFO Program is an **individual permitting process** for farms with more than 700 mature dairy cows (whether milking or dry), 1,000 beef cattle or cow/calf pairs, 1,000 youngstock or heifers, 500 horses, 55,000 turkeys, or 82,000 laying hens (without a liquid manure handing system). The LFO law prohibits discharges of wastes from a farm's production area to waters of the state, requires adequate and satisfactory waste storage, and requires the farm to land apply manure, compost, and other wastes

according to a nutrient management plan. Unlike the MFO Program, LFO permits are individual to each farm and also regulate odor, noise, traffic, insects, flies, and other pests.

In 2010, the Agency performed a total of 503 inspections/visits to farms to determine compliance with the Accepted Agricultural Practices Regulations, the Medium Farm General Permit and Large Farm Operation individual permits and to offer technical assistance.

<u>AAP Compliance</u>: In 2010, one hundred and fifty-two (152) inspections were conducted into alleged violations of the AAPs. Sixty-eight (68) or 45% of inspections were conducted in response to complaints from the public. Eighty-four (84) or 55% of AAP inspections resulted from field staff or office-generated compliance checks, or compliance checks requested by the landowner. It is interesting to note that while the MFO and LFO programs are inspection-based compliance programs, the AAP enforcement program has also, over the past few years, been shifting steadily towards more of an inspection-based program as opposed to being driven by complaints from the public.

As a result of inspections conducted in 2010, four (4) small farms have received formal enforcement actions, and one additional enforcement action is pending. Three farms received corrective action letters (CALs), while one farm received an administrative penalty for violations of an assurance of discontinuance issued in 2009. The pending enforcement action is a corrective action letter. The final violation rate, including the one pending action is 3.0%. The resulting AAP compliance rate of 97% includes 15 farms found in violation of the AAPs that made immediate corrections in the field in response to assistance from Agency staff. Three (3) cases have been referred to an Agricultural Resource Specialist for follow-up technical assistance, 3 cases were referred to the Agency of Natural Resources as potential direct discharges, and one case was referred for engineering assistance. Six (6) cases are in continuation and require follow-up compliance checks in order to close the cases.

MFO General Permit Compliance: In 2010, a total of 290 visits were made to medium farm operations. In 2009, the Agency focused on performing initial facility evaluations on Medium Farms to check for compliance with the state's MFO General Permit conditions. In 2010, 65 follow-up inspections (inspections conducted subsequent to the initial facility evaluation) were conducted on medium farms. This number includes 6 inspections of medium farms conducted with the Department of Environmental Conservation (DEC) and 9 inspections conducted with staff from the Region 1 Office of the Environmental Protection Agency (EPA). These joint inspections were conducted in order to check for compliance with both the state MFO general permit and the Federal Concentrated Animal Feeding Operation (CAFO) program requirements. Agency staff also conducted 50 regulatory follow-up visits to follow up on previous enforcement actions to ensure progress continues, and 172 visits to provide technical assistance. Three (3) inspections of medium farms were conducted in response to complaints received.

In 2010, 9 medium farms received formal enforcement actions, and one enforcement action is pending. Six (6) MFOs received corrective action letters for violations of the MFO general permit and one of these farms received a cease and desist order, assurance of discontinuance and an administrative penalty after initially receiving a corrective action letter. One MFO received a letter of warning for violations of a winter spreading exemption, and two MFOs received an administrative

penalty and an assurance of discontinuance. The pending enforcement action is an assurance of discontinuance to bring an MFO into compliance with the general permit requirements.

<u>LFO Individual Permit Compliance</u>: In 2010, a total of 61 visits were made to large farm operations. Agency staff conducted 29 inspections for compliance with farms' individual LFO permits. Agency staff also performed 19 regulatory follow-up visits to evaluate progress on addressing compliance issues previously identified, while 6 visits were made to provide technical assistance. Seven (7) visits were initiated in response to complaints received. In 2010, two LFOs received formal enforcement actions (one received an assurance of discontinuance, and another received a corrective action letter followed by an administrative penalty and final order). Two LFOs had violations that were resolved in the field.

Table 1 summarizes the number of inspections conducted in 2010 to determine compliance of small farms with the Accepted Agricultural Practices Regulations, medium farms with the MFO General Permit, and large farms with their LFO Individual Permit.

NOTE: As indicated in the attached investigation tracking summary table (Table 5), compliance check surveys were conducted to ensure compliance with the winter manure spreading ban. Each survey is logged as a single investigation, but each survey covers a number of farms in a given area. In 2010, 11 pre-winter spreading ban compliance checks covering approximately 83 farms were conducted to ensure that farmers were emptying their pits and getting ready for the winter spreading ban. Once the ban was in effect, thirty-two (32) compliance checks were conducted to ensure that no manure spreading was occurring during the winter spreading ban. These checks covered approximately 250 farms. So, while only 43 inspections are logged for these compliance check efforts, a total of more than 330 farms were found to be in compliance at the time of these checks.

Table 2 illustrates the number of inspections conducted in each of Vermont's watersheds and the enforcement actions taken. **NOTE:** This table only addresses the inspections conducted to determine compliance with the AAPs, and those inspections of MFOs and LFOs that either lead to the issuance of an enforcement action, or were undertaken in response to complaints from the public (these investigations are summarized in Table 5). A number of inspections, such as surveys for compliance with the winter manure spreading ban, encompass more than 1 watershed. Therefore, the number of investigations on a watershed basis will exceed the absolute number of inspections conducted. The enforcement action taken is paired with the designation "SFO" for small farm, "MFO" for medium farm, and "LFO" for large farm. In many cases, field agents address and correct issues in the field without the need for a written enforcement action. In 2010, seventeen (17) cases (15 SFOs, 2 LFOs) involved providing farmers with verbal warnings of violations and suggestions for immediate corrections in the field (these cases are indicated with "verbal"). In a number of cases corrective actions are in process, and are reported here as "continuing", or "CON".

NOTE: A number of violations reported as being solved in the field, as well as those receiving formal enforcement actions, involve landowners with small livestock operations that are not aware that the AAPs apply to their activities. The Agency is seeing more of these types of operations, possibly due to the current economic conditions and the desire of people to raise their own food. In these cases, the violator is educated as to the requirements of the AAPs and requested to correct the situation. In cases where the landowner is cooperative and eager to correct the situation, no formal enforcement action is taken. If it appears that the landowner is resistant to corrective action, a formal enforcement action is taken.

Table 3 illustrates the general nature of complaints received and compliance checks conducted. Some inspections addressed more than one concern, so the numbers in this table will exceed the number of inspections conducted. The majority of complaints, as in past years, were related to manure. General concerns included proximity of manure spreading or stacking to surface water, wells or property boundaries, or runoff from stacked manure to water. This table also reflects inspections and regulatory follow-up visits on MFOs and LFOs (also detailed in Table 1).
