WEIGHING & MEASURING DEVICES – EXPLANATIONS SHEET

No person/business shall operate a commercial weighing and measuring device without first obtaining a license from the Vermont Agency of Agriculture, Food & Markets.

Medium Scale(s) – Portable Platform

- Portable platform scales are used in direct sales.

Medium Scale(s) – Fish & Wildlife Scales

- Portable platform scales used for reporting game for the Department of Fish & Wildlife. These scales are exempt.

Medium Scale(s) – Other

- Scales with a capacity of 101 – 3,000 pounds used in commercial trade.

Vehicle Tank Meter(s)

- A measuring device which is affixed to a tank mounted on a vehicle used for the measurement and delivery of petroleum products, except liquefied petroleum gas.

Truck Mounted Propane Meter(s)

- A device used to measure liquefied petroleum gas.

Propane Fill Station(s)

- Permanently installed propane storage tank and meter, used for the refilling of cylinders and/or tanks mounted on vehicles.

Bulk Plant Meter(s)

- A device used to measure fluid or gas moving from storage tanks to tanks mounted on vehicles.

Vehicle Scale(s)

- A device adapted to weighing highway, farm, or other large industrial vehicles, except railroad freight cars, loaded or unloaded.

Heavy Duty Scale(s)

- A weighing device with rated capacity in excess of 3,000 pounds.

Hopper Scale(s)

- A weighing device designed for weighing bulk commodities, whose load-receiving element is a tank, box or hopper mounted on a weighing element.
