By Signing This License You Certify That You Are In Good Standing with the Requirements Below. If You Certify Falsely That You Are In Good Standing You May Be Subject To Prosecution.

By law (15 V.S.A. Section 795), the State may not renew a license for trade or business unless the licensee first certifies that he or she is in good standing with any order to pay child support.

By law (32 V.S.A. Sec. 3113), the State may not renew a license for business or trade unless the licensee certifies, under the pains and penalties of perjury, that he/she is in good standing with the Department of Taxes. The maximum penalties for perjury are fifteen (15) years in prison, a \$10,000 fine or both.

- Good standing means:
- that no taxes are due;
  - the liability is on appeal;
  - the licensee is complying with a State authorized payment plan; or
  - the immediate payment would cause unreasonable hardship. (If you are claiming hardship, please contact the licensing agency for further information.)

**I hereby make application for a Livestock Packer license as required by Title 6 V.S.A., Chapter 63 Vermont Statutes as amended to buy, sell, auction and transport livestock. License period begins July 1 and ends June 30 of the following year. I hereby agree payment in full will be made to the seller not later than 72 hours following the sale of animals. This application is accompanied by a Surety Bond in the amount of \$10,000 or Continuation Certificate for an indefinite term bond as prescribed in Title 6 V.S.A, Chapter 63, Section 764 as amended in 1989. In lieu of a surety bond, the Secretary may accept a federal packer and stockyards administration trust agreement, or an irrevocable letter of credit. The Secretary of Agriculture, reserves the right to request such further information as he deems necessary to act upon the applicant's request for a livestock packers license. I have been provided with and understand Rules Governing the Importation of Domestic Animals and Duties of Packers 6 V.S.A. Chapter 63, Section 768.**
