(Please initial)____: I hereby certify that I understand that all nursery stock transported into the state of Vermont for sale, distribution or installation shall be accompanied by a valid certificate of inspection, or a reasonable facsimile, or other certification from the state, which the consignment comes from or a United States government inspector stating the nursery stock is believed to be free of injurious pests or plant diseases.

(Please initial)____: I hereby certify that I understand that there exists a quarantine against the states of Alaska, California, Connecticut, Delaware, Maryland, Massachusetts, New Jersey, New York, Oregon, Pennsylvania, Rhode Island, Virginia, Washington, and the District of Columbia against the importation of hemlock seedlings, nursery stock and lumber products. Hemlock seedlings and nursery stock are only admissible into the state of Vermont if they are accompanied by a state or federal certificate of inspection declaring that the said material is free from Hemlock Wooly Adelgid.

NURSERY DEALER LICENSE APPLICATION INSTRUCTIONS

The nursery dealer-licensing program is mandated by 6 V.S.A., Chapter 206, Sections 4021-4031. **This law states that any business or person purchasing, selling or distributing live plants shall annually apply for and receive a nursery dealer's license from the Secretary of Agriculture.** If this law does not apply to your business than please indicate so on the attached form and return it to the Agency. We will then remove you from our mailing list.

The purpose of this law is to prevent the movement of economically damaging pests such as plant pathogens, insects, mites and noxious weeds that have the potential to cause economic harm to Vermont's agricultural community and natural environment. During the earlier part of this century, several problems were imported into this country, such as: Chestnut Blight, Dutch Elm Disease, Birch Leafminer, Japanese Beetle, etc... Under this law, officials from the Agency of Agriculture, Food & Markets may inspect nursery stock in the possession of licensed dealer's, as they may deem necessary. No person may legally sell live plants in the state of Vermont without a nursery dealer's license.

In 2010, there were changes made to the nursery law, including the introduction of a nursery licensing/inspection fee. The fee is either \$30 or \$60, depending on the size of your nursery operation. Please familiarize yourself with the list of new and emerging plant pests of concern to nurseries (*visit: <http://www.vermontagriculture.com/ARMES/plantindustry/index.html> for list*). This list was generated based on both the economic and ecological threats presented by these species based on their distribution, host species, life histories and potential to become established in Vermont. Help us keep these pests out of Vermont, if you see signs of these pests in your area please notify us at the Agency of Agriculture immediately.

As a reminder, a certificate of inspection stating that the plants are free of Hemlock Woolly Adelgid must accompany all shipments of hemlock into Vermont. Imports of hemlock are prohibited from those areas where this insect is established (including areas of AK, CT, DE, GA, MD, MA, NH, NJ, NY, NC, OR, PA, RI, SC, TN, VA, WA, WV, the District of Columbia, and the Canadian Province of British Columbia). Receiving nurseries failing to comply with this requirement may be subject to administrative action and monetary penalties. Part II of the application is only to be completed by nurseries/greenhouses that are actively growing plants in Vermont. This is necessary in order for the business to become certified and be issued a Certificate of Inspection by the Agency.

A certified nursery/greenhouse is then eligible to ship plants out of Vermont. This is necessary since plants entering all other states are required to be accompanied by a Certificate of Inspection issued by a state or federal agency, or face the possibility of destruction upon arrival in the receiving state.
