

Vermont COVID-19 Agriculture Assistance Program Application Summary

The Vermont State Legislature appropriated Coronavirus Relief Funds for the Vermont COVID-19 Agriculture Assistance Program (VCAAP) in Act 138 (S.351), Act 137 (H. 966), Act 120 (H.961), and Act 154 (H.969). The purpose of these grants was to stabilize agricultural businesses and organizations based on their lost revenues and expenses related to business interruption caused by the COVID-19 public health emergency.


The Vermont Agency of Agriculture, Food & Markets awarded VCAAP grants to eligible farmers, meat and poultry processors, commercial slaughterhouses, farmers' markets, value-added food product businesses, forest products businesses, producer associations, dairy producers and processors, agricultural fairs, schools and registered or licensed child care providers,. Each grant program had maximum funding amounts based on farm size, processor capacity, or business revenues.

Total Amount Awarded by County






Total Amount Requested

Dairy Producers and Processors Application Summary

793 Awards for \$18.3M

The Dairy Producer and Processor Application was launched on July 17, 2020, closed on October 1, and then relaunched on October 19, with legislative changes, and officially closed again on November 15, 2020.

Milk producers, if qualified, were eligible for two grants up to the following maximum amounts:

- Small farms shall receive up to \$18,300
- Certified small farms shall receive up to \$34,300
- Medium farms shall receive up to \$56,000
- Large farms shall receive up to \$100,000

Dairy processors, if qualified, were eligible for two grants up to the following maximum amounts. Dairy processors that process:

- Less than 500 lbs. of milk per day shall receive up to \$31.000
- From 500 9,999 lbs. of milk per day shall receive up to \$40,000
- From 10,000 49,999 lbs. of milk per day shall receive up to \$50,000
- 50,000 lbs. or more of milk per day shall receive up to \$60,000


Average Days from Submitted to Awarded



Agriculture and Working Lands Application Summary

302 Awards for \$6.7M

The Agriculture and Working Lands Assistance Application launched on Wednesday August 19, 2020, closed on October 1, and then relaunched on October 19, with legislatively initiated eligibility changes, and closed officially on November 15, 2020. On November 18, 2020, AAFM requested a transfer of \$2M from Dairy (S. 351) to Agriculture and Working Lands appropriation (H.961) due to increased demand in this program.

Agriculture and Working Lands Applications, if qualified, were eligible for one grant up to the maximum amounts. Applicants with 2019 annual gross sales of:

- \$10,000 \$24,999 shall receive up to \$2,500
- \$25,000 \$49,999 shall receive up to \$5,000
- \$50,000 \$99,999 shall receive up to \$10,000
- \$100,000 or more shall receive up to \$20,000
- \$250,000 or more shall receive up to \$50,000

To be eligible for Agriculture and Working Lands Assistance, an applicant must demonstrate that their business is one of the following categories with annual gross sales exceeding \$10,000:

- A farmer
- Commercial processor
- Commercial slaughterhouse
- Farmers' market
- A value-added food product business
- A forest products business
- A dairy producer or processor
- An agriculture producer association




Average Days from Submitted to Awarded







Farm to School

22 Awards for \$100,000

The passage of Act 154 (H.969) allocated \$100,000 in Coronavirus Relief Funds (CRF) to the Vermont Agency of Agriculture, Food & Markets Farm to School Program to address the effects of the COVID-19 pandemic. The Vermont COVID-19 Agriculture Assistance Program (VCAAP) Farm to School Application reimbursed schools and registered or licensed child care providers for equipment and supply purchases that were necessitated by the COVID-19 global health pandemic and help support farm to school program goals.



Agricultural Fairs

12 Awards for \$500,000

The Vermont State Legislature appropriated funding in Coronavirus Relief Funds for the purpose of awarding grants to Vermont's agricultural fairs that have suffered lost revenues or expenses caused by the COVID-19 public health emergency. Governor Scott signed this legislation, Act 138, on July 2, 2020. The Vermont Agency of Agriculture, Food & Markets (VAAFM) awarded funds to agricultural fairs that are registered with VAAFM and have experienced income loss, additional expenses, and event disruption.

Farmers Markets

7 Awards for \$12,643

The Vermont COVID-19 Agriculture Assistance Program (VCAAP) Farmers' Markets Relief Application was created to alleviate the economic hardship suffered by small and medium-sized farmers' markets due to the COVID-19 pandemic. This application was open to farmers' markets with less than \$10,000 in annual gross sales. Farmers' markets with annual gross sales of more than \$10,000 could apply for assistance under the Agriculture and Working Lands Application.




Customer Experience Survey Summary

VAAFM sent 1,241 survey invitations to VCAAP grantees, applicants, those who started an application but did not apply, and service providers who assisted applicants. 409 individuals responded.

How much did receiving a VCAAP grant help to stabilize your business or organization?


