Notes as Followed

Dairy

- (Orleans) During the listening session the Vermont Milk Brand was discussed. This has been attempted in the past and ultimately failed. Perhaps we could look at why that failed and if there is a way to learn from the attempt. Vermont already has the kinds of farms that are worth marketing to consumers. Farms that practice in ways that are good for the environment, the animals, the ultimate nutrition of the product and the Vermont Landscape.
- (Orleans) Agency of Ag needs to think economies of scale the dairy farmers are the ones who own the land, pay the property taxes and keep the working landscape open and viable. The Agency needs to decide if that is the priority of not.
- (Orleans) Replacing dairy farmers with smaller scale, alternative ag will not necessarily
 replace that gross revenue traditional dairy is providing. It will have a ripple effect the
 loss of those farms shows us that already. And if traditional dairy is not the way the
 state wants to go what are the viable economic alternatives that allow farmers to
 maintain that land and all the costs that entails.

• (Rutland) I appreciate all the equity work being done and want to encourage the Agency of Agriculture to keep up the good work as there is always plenty to be done to increase equity.

Grants

- (Windsor) Grant programs for those that were effected by the FREEZE on May 17-18, 2023.
 - (Orleans) Simplify grant applications and reporting for farms requiring subsidy to operate. Provide a database showing all available grants in one place and organized by business/farm/institution opportunities. If there is a genuine interest in preserving small dairy farms, expand programs to support those farmers directly.
- (Orleans) I think workshops on accessing grants for the "lay farmer", without having to pay a grant writer to navigate the often complex process would be helpful. More than just the informational sessions you offer.

- (Orleans) Use grant monies efficiently so more of it actually goes to the farmers / partners supporting them.
- (Orleans) The NRCS office in Newport is so helpful in navigating and applying for grant opportunities.
 - Orleans) Additionally the support provided to make sure the farm is in compliance and up to date with all record keeping is essential to operations and farm strategy. The local office means farms have support from professionals who understand the community and have a more direct connection to the farm.
- (Chittenden) maple grants; hope for more each year
- (Orleans) I think the Agency of Ag should think of leveraging its grant monies to help maintain the existing farming infrastructure.
- (Orleans) All the grants are for "new, innovative, etc". and honestly farmers are just trying to break even and maybe take a meager salary for once. It sends a message that farmers are not innovative or already doing things well. And if you are there is no financial recognition for already having done that.
- (Orleans) With the rising costs of everything, matching funds from the farmer should be on a sliding scale. Small farms just can't manage the match sometimes because we just don't have the cash flow.
- (Orleans) Grants etc should be reflective of the economic impact that farm has on its local economy, ie a 150 cow dairy farm creates a gross revenue of nearly 1 million dollars that supports local economy through jobs, supporting local vendors etc.
- (Orleans) The amount of grants available to those farms should reflect that. ie \$5000 for a local CSA/fruit and veggie farmer that has a gross annual revenue of \$100,000 vs \$5000 in support to a dairy farmer (ie the DMC reimbursement) who has a gross revenue of \$1000000, it doesn't even equate.
