## Maple Inspection Results (Jan. 2024 to Dec. 2024)

Food Safety & Consumer Protection Division Vermont Agency of Agriculture, Food & Markets

### Summary

Food Safety and Consumer Protection (FSCP) Division staff conducted 14 maple product inspections at retail locations between January 2024 and December 2024. See Table 1.

FSCP staff reviewed product labels and sampled maple syrup to ensure compliance with Vermont grade standards for quality, food safety, and labeling. A total of 33 maple syrup products were graded from 25 different producers and distributors. 6 regulatory letters were issued for noncompliance issues found.

24 of the 33 maple syrup samples, or 73%, were found to be overall in compliance. This is an increase from last year when 65% were found in compliance. Note, a product that was missing a batch code was considered in compliance as long as it had no other noncompliance issues.

Color was the most common reason for syrup found out of compliance. 5 of the 9 maple syrup products found out of compliance were too dark for grade.

Other notable issues found:

- Off-flavors: Musty (1) and buddy (1)
- Clarity: poorly filtered (1)
- Density: low (2)
- Labeling: no batch code (6) and no grade designation (2)
