## Pasture \& Surface Water Fencing (PSWF) Program



## Program Information:

> Free technical assistance from experienced grazing specialists.
> Financial assistance to implement improved pasture management, which may include eligible practices as listed.
> Reimburse project expenses up to $90 \%$ of the cost to install infrastructure that will improve pasture management, up to the farm's grant amount.
> Up to $\$ 15,000$ grant award per farm when the project has livestock exclusion from surface waters.
> Up to $\$ 10,000$ per farm when there is no livestock exclusion from surface waters necessary, but where rotational grazing will be implemented or improved. Rotational grazing requires moving livestock frequently enough to implement a prescribed grazing plan that meets the goals of the PSWF program.

The Pasture Surface Water Fencing (PSWF) program provides pasture management technical assistance and financial assistance to Vermont farmers. This program intends to improve water quality and on-

## Eligibility:

$>$ Farm required to comply with the Required Agricultural Practices.
$>$ Priority is given to farms that have at least 4 acres for the raising, feeding and management of at least five cattle or cows, 15 goats or sheep, four equines, or three camelids.
$>$ Farm manages pastureland where water quality will benefit from implementation of improved pasture management and eligible and/or necessary conservation practices.
$>$ Operator must have ownership or land control for the term of the agreement (10 years). Written lease agreements are required for leased land.
> Have an insurance policy that allows for the State and its employees and officers to be listed as additional insured.

Please note the following information about this grant program:
$>$ Application does not guarantee an award.
$>$ Grant agreements must be in place prior to the start of implementation and prior to purchase of materials.
$>$ Farmer is responsible for financing the project during construction and receives reimbursement upon certified project completion.
$>$ Final payment is determined by actual project costs as documented by itemized invoices.
> Farmer's equipment and labor costs are eligible for reimbursement.
